Position Purpose

The Lead Pharmacist – Western Health at Home Division is responsible for overseeing, coordinating, optimising, and managing pharmacy services provided to Western Health at Home patients receiving care within clinical settings, virtually and in the home. The primary services that Pharmacy supports across the division include:

- Hospital in the Home
- Rehab at Home
- GEM at Home
- Community-Based Transition Care Program
- Residential In-Reach
- 1F Integrated Care Hub
- Community Care Coordination

This role provides leadership and strategic guidance for the Western Health at Home pharmacy service, ensuring alignment with Western Health medication governance and pharmacy practices and best practices in clinic and home based healthcare delivery to reduce avoidable hospital presentations and inpatient admissions.

This role is also responsible for identifying and implementing service improvement opportunities, developing innovative models of care and conducting continuous quality improvement and assurance activities. The Western Health at Home Pharmacist will also take ownership of all procedural aspects of pharmacy services provided to the Western Health at Home Division.

Business Unit Overview

The Division of **Western Health at Home** provides a comprehensive range of inpatient, clinic-based and home-based services. Our multidisciplinary workforce of over 1,000 employees includes medical, nursing, pharmacy, allied health and administration staff. Western Health at Home services provide care from all Western Health campuses and within patients' homes, including residential aged care, supported accommodation and custodial settings. The Division is rapidly expanding to meet the needs of the community through the delivery of innovative, integrated and patient centred care.

Western Health at Home services support patients across the continuum of care with the primary objective to support patients to live more healthy days at home. Our diverse range of services, clinics and units collaborate to reduce avoidable hospital presentations and support early, sustainable hospital discharges. Through multidisciplinary service delivery, integration with primary care, research and clinical trials our division supports the detection, management and secondary prevention of chronic disease.

The Division's medical specialties include Renal, Endocrinology and Diabetes, Geriatric Medicine and the General Practice (GP) Integration Unit. Western Health at Home provides a range of acute and subacute services that deliver hospital level care within the comfort of patients' home. These services, which include Hospital in the Home, Rehab at Home, GEM at Home, Community-Based Transition Care Program, Residential In-Reach and Dialysis at Home, deliver healthcare that would otherwise be provided within an inpatient setting.

Western Health at Home's range of community-based care and specialty assessment clinics provides comprehensive care chronic disease management. The Division operates chronic dialysis units at all main Western Health campuses, with acute units at Sunshine and Footscray Hospitals. Western Health at Home also manages a primary healthcare service within Dame Phyllis Frost Centre, a maximum-security women's prison located in Melbourne's west.

Key Responsibilities

Leadership and Strategy:

- Provide strategic guidance and leadership to optimise pharmacy services across all Western Health at Home teams ensuring high-quality patient-centred care
- Identify and drive service improvement initiatives focused on innovation to enhance patient outcomes, including the development, implementation, monitoring and recording of divisional pharmacy KPIs and interventions to assess performance and promote continuous improvement
- Develop innovative models of care that support patients to remain in their homes
- Provide direct line manager support to Western Health at Home Senior Pharmacists and supervise the Clinical Rotational Pharmacists, ensuring adherence to Western Health's key behaviours and effectively managing any deviations from documented staff and role expectations
- Actively participate as a professional advisor to the Western Health Pharmacy senior management team
- Serve as a role model and mentor, promoting good work practices, professional development and ethical behaviour
- Foster a learning environment that promotes teamwork in delivering pharmacy services
- Demonstrate the value of pharmacy services to customers and effectively market these services
- Provide leadership in monitoring trends and new developments in medicines relevant to the Division
- Review and modify work practices pertaining to Western Health at Home Pharmacy services as appropriate.

Provision of Care:

- Provide clinical and operational pharmacy services to patients within all Western Health at Home Teams to support timely transitions from hospital to home and facilitate community-based care, enabling patients to remain in their homes
- Provide daily clinical pharmacy services as required
- Ensure clinical services are provided in compliance with Advanced Pharmacy Australia (AdPha)'s Standards of Practice for Clinical Pharmacy

Our Vision

- Investigate and assess reported clinical incidents and identify trends of medication-related errors
- Assist in the coordination and collation of requests for compassionate use of medication supply by liaising with all relevant stakeholders
- Coordinate the provision of pharmacy services to ensure that an efficient, effective, consistent and high-quality service is provided
- Ensure that documentation of tasks is accurately and appropriately completed
- Develop and maintain policies and procedures relevant to the provision of pharmacy services within the Western Health at Home Division
- Oversee and maintain the updating of medication administration protocols in the Western Health at Home setting in collaboration with the in-house policies and procedures officer
- Oversee and ensure the supply of required pharmaceuticals for patients and participate in the rationalisation of medication supply
- Perform other duties as delegated by the Operational Management team of the Western Health at Home Division or Director of Pharmacy

Collaborative Practice:

- Maintain and report on the Western Health at Home Pharmacy Service Plan by submitting quarterly progress reports to the manager of the service
- Collect and respond to feedback from nursing and medical staff regarding Western Health at Home pharmacy services
- Participate in and coordinate quality assurance activities, ensuring compliance with Standard 4 accreditation requirements
- Collaborate with clinical services on joint quality activities, including clinical audits to enhance service delivery
- Engage in multi-disciplinary committees and working groups within Western Health
- Facilitate communication of patient medication requirements with carers and/or relevant health care providers in the community
- Complete medication management reviews to ensure effective and safe medication management to optimise patient care
- Participate in the training of medical and nursing staff

Professional Development: Education, Training and Research

- Provide expert advice on Western Health at Home pharmacy services and communicate this effectively to relevant staff
- Develop and implement clinical procedures relating to the Western Health at Home services, ensuring that all clinical pharmacists understand and are adequately trained
- Participate in the department's performance development program
- Oversee an education portfolio for Western Health at Home services, including training and assessment of all pharmacy staff, and clinical education for nursing and junior medical staff
- Develop structured training programs and an education framework in collaboration with the Education Pharmacists for all pharmacy staff
- Maintain affiliation with professional bodies
- Participate in relevant conferences, seminars and related educational activities
- Identify research opportunities and coordinate quality assurance projects related to Western Health at Home pharmacy services
- Engage proactively in research, publications and presentation relevant to the Division's pharmacy practice
- Lead practice research in collaboration with the Lead Pharmacist- Medication Safety, Pharmacy Team Leads and Senior Pharmacy Management to improve clinical pharmacy services
- Assist divisional staff with research grants and the development of research protocols, ethics committee submissions and publications

Operational Management and Service Development:

- Continuously develop the Western Health at Home clinical pharmacy service profile by reviewing and modifying work practices as appropriate
- Coordinate suitable training and handover for the Senior Pharmacists Western Health to assume the Lead Pharmacist role, ensuring uninterrupted service during leave periods

Our Vision

- Coordinate recording and analysis of pharmacist interventions and workload statistics for KPI reporting
- Oversee the medication expenditure, identify cost-saving opportunities and lead implementation strategies with the Lead Pharmacist- Medicines Strategy . This includes participation in tenders, purchasing agreements and conversion to alternative drug therapies as required.
- Oversee optimal inventory management of pharmaceuticals within the Western Health at Home Unit
- Ensure compliance with Western Health's Drug Formulary and Pharmaceutical Utilisation Committee decisions
- Produce and review monthly medication usage reports for WH Pharmacy and Nursing and Medical within Western Health at Home Unit
- Proactively recommend cost-effective medication therapies
- Optimise PBS claiming, ensuring prescriptions meet HIC requirements and comply with Western Health's prescribing and dispensing procedures
- Deliver the Key Organisational Accountabilities which are aligned with the Western Health strategic aims as needed

- Previous experience in the provision of at home or transitions of care pharmacy services
