<b>Position Purpose</b>
<p>The Grade 1 Occupational Therapist is required to provide quality patient care through provision of evidence based, person centred, occupation focussed Occupational Therapy, in partnership with patients, their significant others and members of the multidisciplinary care team, in accordance with Western Health policies and procedures, and Occupational Therapy Service clinical guidelines. They will demonstrate effective communication and active participation within the OT service and multidisciplinary team. Rotations through different clinical areas usually occur every six months</p>
<b>Business Unit Overview</b>
<p>The Operations Directorate is one of the largest and most complex directorates within Western Health providing Western Health's patient care and contacts. - Participate in relevant committees, working groups and meetings as requested
- Demonstrate knowledge of resources relevant to work area
- Contribute to a culture that promotes effective teamwork, encourages cohesion and ensures staff feel valued and contributions are acknowledged
- Hold accountability for own actions and seek guidance and support from appropriate employees when limited by own skills and experience
- Comply with confidentiality obligations with regard to patients, consumers and colleagues
- Participate in learning that will enhance personal knowledge and continuing professional development
- Consult with senior staff when dealing with difficult situations
- Demonstrate ability to identify a problem within a service and take it to a higher level for resolution
- Where designated, take a support role in student education that is timely, flexible and responsible
- Actively participate in regular clinical supervision, demonstrating ongoing development of clinical skills and reflective practice as identified in supervision plan
