### Position Purpose

The Grade 2 Occupational Therapist will have a key role in providing and ensuring best-practice person centred, occupation-focused patient care and excellence in patient care for Specialised Rehabilitation Clients.

Specialised Rehabilitation Program (SRP) is integral to supporting the safe and timely discharge of patients from Western Health inpatient wards and ensuring that recovery of all clients is optimised. SRP works collaboratively with the Rehab at Home program, providing backfill and support to this bed substitution program. Service may therefore include same day or next day service to patients discharged from inpatient wards as part of the Rehab at Home program. Rehab at Home provides intensive rehabilitation to people discharged early from hospital.

In addition to the Grade 2 Occupational Therapists are responsible for developing staff and students, including direct supervision and training of Grade 1 rotating Occupational Therapists and allied health assistants; and co-ordination of student placements and tutorials. They will also be involved with the wider WH Occupational Therapy service.

Interventions are delivered via individual or group-based treatment. There may be opportunities to develop skills in robotic upper limb rehabilitation. Treatment may be provided in a centre-based, home or community setting via face-to-face care or telehealth.

The incumbent may be required to work across Sunshine and Williamstown hospital Specialised Rehabilitation teams or at any campus of Western Health as required.  
This position but may involve rotations to other areas across the continuum of care within the Western Health at Home Division.

## Business Unit Overview

### Division

The Division of Western Health at Home provides a comprehensive range of inpatient, clinic based and home-based services. Our multidisciplinary workforce of over 1,000 employees includes medical, nursing, pharmacy, allied health and administration staff. Western Health at Home services provide care from all Western Health campuses and within patient's homes, including residential aged care, supported accommodation and the custodial setting. The division is rapidly expanding to meet the needs of the community through the delivery of innovative, integrated and patient centred care.

Western Health at Home services support patients across the continuum of care with a primary objective to support patients to live more healthy days at home. Our breadth of services, clinics and units work collaboratively to reduce avoidable hospital presentations and support early and sustainable hospital discharges. Through multidisciplinary service delivery, integration with primary care, research and clinical trials our division supports the detection, management and secondary prevention of chronic disease.

The divisions medical specialties include Renal, Endocrinology and Diabetes, Geriatric Medicine and the General Practice (GP) Integration Unit. Western Health at Home provides a range of acute and subacute services that deliver hospital level care within the comfort of a patient's home. These services include Hospital in the Home, Rehab at Home, GEM at Home, Community Based Transition Care Program and Dialysis at Home, which deliver healthcare that would otherwise be provided within an inpatient setting.

Western Health at Home's breadth of community-based care and specialty assessment clinics provide comprehensive care to support the management of chronic disease. The division has chronic dialysis units located at all Western Health main campuses and acute units at Sunshine and Footscray Hospital. Western Health at Home manages a primary healthcare service within Dame Phyllis Frost Centre, a maximum-security women's prison located in Melbourne's West.

### Specialised Rehabilitation Program

Specialised Rehabilitation Program (SRP) aims to assist clients and their carers to reach their maximum potential and independence through the provision of multi-disciplinary rehabilitation. Clients are provided with an individualised, short-term, goal-orientated therapy program which emphasises self-management and education. Sessions are conducted in the centre, at home and/or via Telehealth/telephone.

### Rehabilitation at Home Program

Rehabilitation at Home Program is a virtual, admitted program that facilitates early discharge from the inpatient wards. It provides intensive therapy, up to 3 hours per day, during the period of transition from inpatient care to outpatient/community care. Multidisciplinary therapy is conducted in the home, centre or via telehealth. Referrals are accepted from Western Health acute and subacute wards and other health services.

### Division of Allied Health

Allied Health provides a range of evidence based, client centred, specialist services at Western Health, across the care continuum, from admission within the emergency department through to discharge in the community. These services work across the spectrum of life, from neonates to the elderly. The predominant focus of Allied Health is the return and optimisation of an individual's function, and wellbeing, from both physical and psycho-social perspectives. Activity is aligned with Western Health's Best Care Model and CARES values. Allied Health involvement is pivotal to efficient and effective multidisciplinary team functions, discharge planning and patient centred care. Western Health employs a range of Allied Health disciplines, each with unique specialist tertiary training and skills, including Audiology, Clinical Psychology and Neuropsychology, Exercise Physiology, Language Services, Nutrition and Dietetics, Occupational Therapy, Pastoral Services, Physiotherapy, Podiatry, Social Work, and Speech Pathology.
