Position Purpose

A Nurse Practitioner Candidate (NPC) is a highly experienced advanced practice registered nurse, undertaking a Nurse Practitioner Master's program to achieve endorsement as a Nurse Practitioner (NP) with the Nursing and Midwifery Board of Australia (NMBA). The NPC role is a transitional role where the candidate is gaining the required experience and knowledge, whilst completing their Master's-level education and working under supervision to develop the advanced clinical skills necessary for independent practice.

NPCs work under the supervision of an experienced NP or senior medical professional while gaining practical experience in their specialty area. Unlike endorsed Nurse Practitioners, NPCs do not yet have independent prescribing or diagnostic ordering rights and must work within established medical guidelines. They progressively develop the skills and competencies required to function autonomously as an NP, integrating advanced clinical practice, education, leadership, and research within their scope of practice. NPCs require medical, pharmacology, clinical and professional nursing supervision throughout their program.

The NPC will contribute to providing quality health and well-being services for consumers demonstrating proficient to expert behaviours across the five domains of leadership, research, evidence-based practice, education & learning and clinical expertise as identified in the Western Health Nursing and Midwifery Professional Practice Framework.

The NPC pathway enables incumbents to undertake the advanced clinical assessment, diagnostics and pharmacology management in the clinical setting in order to achieve their academic requirements and university assessments. The Australian Health Practitioner Regulation Agency (AHPRA) and the NMBA regulate NPCs.

The NPC is responsible and accountable for making professional judgements about the patient's condition when the patient's condition is beyond their scope of practice and seek consultation with a medical officer or other members of the health care team based on the NMBA decision making framework, codes and quidelines.

The Nurse Practitioner Candidate (NPC) – Hospital in the Home (HITH) role will support the delivery of safe, high-quality acute care in the community for patients who would otherwise require hospital admission. Common conditions currently managed by the HITH team include:

- Cellulitis, DVT, pneumonia, COPD exacerbations
- Heart failure monitoring
- Wound and drain care post-surgery
- IV therapy (e.g., antibiotics, diuretics, hydration)
- Anticoagulation initiation and monitoring

Operating under the supervision and mentorship of the Medical HITH consultant, the NPC will work towards their Nurse Practitioner endorsement. The NPC will deliver advanced nursing care and progressively build capabilities in assessment, diagnosis, prescribing, and diagnostic decision-making.

The NPC will:

- Deliver person-centred, evidence-based care to acutely unwell adult patients admitted to the acute HITH service.
- Conduct comprehensive clinical assessments, including physical exams and health histories.
- Develop provisional diagnoses in collaboration with supervising authorised practitioner.
- Formulate evidence-based care plans and present them for review.
- Initiate, monitor and adjust clinical care plans, escalating concerns appropriately.
- Participate in daily clinical patient rounds, contributing to patient reviews.
- Order and interpret pathology and radiology tests under supervision of an authorised practitioner.
- Identify appropriate prescribing and administration of medications in line with clinical guidelines and under supervision of an authorised practitioner.
- Review medications for appropriateness, interactions, and patient understanding, and monitor for side effects and therapeutic effectiveness.
- Perform clinical procedures (e.g., IV access, wound care, catheter management). Practice within scope, gradually expanding responsibilities as competencies are achieved.
- Escalate clinical concerns appropriately.
- Liaise effectively with the broader medical team, nursing staff, allied health professionals, GP's, pharmacists and external care provider to coordinate care.
- Contribute to discharge planning, and transition of care pathways.
- Participate in clinical audits, case reviews and quality improvement projects.
- Deliver high quality patient education; teaching patients about medication safety, wound care, symptom monitoring and self-management in chronic disease (e.g., diabetes, heart failure).
- Provide culturally safe and trauma-informed education to diverse patients.

The Division of Western Health at Home provides a comprehensive range of inpatient, clinic based and home-based services. Our multidisciplinary workforce of over 1,000 employees includes medical, nursing, pharmacy, allied health and administration staff. Western Health at Home services provide care from all Western Health campuses and within patient's homes, including residential aged care, supported accommodation and the custodial setting. The division is rapidly expanding to meet the needs of the community through the delivery of innovative, integrated and patient centred care.

Western Health at Home services support patients across the continuum of care with a primary objective to support patients to live more healthy days at home. Our breadth of services, clinics and units work collaboratively to reduce avoidable hospital presentations and support early and sustainable hospital discharges. Through multidisciplinary service delivery, integration with primary care, research and clinical trials our division supports the detection, management and secondary prevention of chronic disease.

The divisions medical specialties include Renal, Endocrinology and Diabetes, Geriatric Medicine and the General Practice (GP) Integration Unit.

Western Health at Home provides a range of acute and subacute services that deliver hospital level care within the comfort of a patient's home. These services include Hospital in the Home, Rehab at Home, GEM at Home, Community Based Transition Care Program and Dialysis at Home, which deliver healthcare that

Clinical expertise

- Perform comprehensive consumer / client assessments that demonstrate skill in the diagnosis and treatment of acute and chronic illness managed within the HITH specialty, whilst working under the supervision of an authorised practitioner and within a defined NPC scope of practice.
- Develop and demonstrate a comprehensive understanding of specific pharmaceuticals and diagnostic tests related to the specified area of practice
- Develop ability to initiate and interpret diagnostic and radiological tests specific to the scope of practice
- Develop ability to safely initiate therapeutic interventions based on accurate knowledge of the characteristics and concurrent therapies of the person receiving the care
- From within the specified scope of practice, identify when to refer consumers / clients to other health professionals as necessary
- Evaluate the effectiveness of the client's response to the clinical management and advise appropriate action
- Accurately document clinical management within prescribed Western Health documentation, ensuring all legal requirements are met in regard to legibility of content and identity of reporter in accordance with Western Health policies and procedures
- Identify potential adverse outcomes and implement proactive strategies to achieve risk minimisation, ensuring consumer / client safety is maintained
- In a consulting capacity, provides clinical nursing expertise and direction in line with clinical standards policies and procedures to both internal and external customers, including providing high level nursing assessment, care planning and interventions/procedures.
- Is responsible for a timely response to referrals and manages and provides assistance to others in prioritisation and completion of tasks such as completion of necessary statistical data, including entry to support financial recuperation as appropriate.
- Act as a primary resource in relevant area and ensure the provision of high quality, culturally sensitive consumer care in partnership with consumers, their significant others and other members of the multidisciplinary care team
- Provides an efficient and customer focused service commensurate with senior status and role.
