<p>Position Purpose</p> <p>Under the written and/or verbal direction of the treating medical clinician/unit the Qualified Orthopaedic Technologist/Technician will perform casting, bracing or splinting duties at the Western, Sunshine and Williamstown Campuses to outpatients and inpatients of Western Health. The Qualified Orthopaedic Technologist /Technician will also provide direction and/or supervision to the Trainee Orthopaedic Technologists.</p>
<p>Business Unit Overview</p> <p>The Adult Specialist Clinics at Western Health provide expert review and management for patients requiring consultation by specialist clinicians. The Specialist Clinic setting acts as a conduit for patients accessing services at Western Health and provides care and ongoing management and ensures referral and communication pathways are in place to optimize the patient journey. Service delivery is provided across the patient continuum of care by the Specialist Clinics Nursing, Referral Management and Patient Management Teams. The objective of the Specialist Clinics coordinated team approach is to improve patient access and processes - in essence this equates to “right patient, right clinic, right time”.</p>
<p>Key Responsibilities</p> <ul style="list-style-type: none"> • Application, modification and removal of casts/splints/braces and Orthopaedic devices • Fully responsible for the safe and effective production of casts that have optimal fit and function • Correctly manage unstable and stable fractures, including the manipulation of fractures • Define the appropriate course of action and prioritisation for a referral and know when to seek further guidance or clarification on a patients treatment • Thorough understanding of fractures, mechanisms their management and potential complications • Report any concerns as to a patient's condition with relevant disciplines • Educate patients on the relevant care specific to their injury within the device • Removal of ‘K’ wires and application of basic dressings • Removal of casts

- Demonstrate flexibility/responsiveness within professional practice/duties/roles and assumes extra responsibility as required to meet organisational priorities and appropriately delegates as necessary
- Where designated, provide high quality supervision to junior staff and students that is timely, flexible and responsible
- Assist in writing procedures and guidelines as required for the ongoing development of the program, and support relevant staff to complete these tasks
- Lead and participate in the development, organisation and delivery of education programs for Western Health staff, external service providers and the community
- Assist in achieving budgetary targets with regards to consumables.
